**Item 2.02. Results of Operations and Financial Condition.**

On May 4, 2015, First BanCorp. (the “Corporation”), the bank holding company for FirstBank Puerto Rico (“FirstBank” or “the Bank”), issued a press release announcing its unaudited results of operations for the first quarter ended March 31, 2015. A copy of the press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.

A copy of the presentation that the Corporation will use at its conference call to discuss its financial results for the first quarter ended March 31, 2015 is attached hereto as Exhibit 99.2 and is incorporated herein by reference. As announced in a press release dated April 27, 2015, the call may be accessed via a live Internet webcast at 10:00 a.m. Eastern time on Tuesday, May 5, 2015 through the investor relations section of the Corporation’s website: [www.firstbankpr.com](http://www.firstbankpr.com) or through the dial-in telephone number (877) 506-6537 or (412) 380-2001 for international callers. The conference number is 10064784.

The Corporation has included in this release the following financial measures that are not recognized under generally accepted accounting principles, which are referred to as non-GAAP financial measures: (i) the calculation of net interest income, interest rate spread and net interest margin rate on a tax-equivalent basis and excluding changes in the fair value of derivative instruments; (ii) the calculation of the tangible common equity ratio and the tangible book value per common share; (iii) the adjusted pre-tax, pre-provision income, (iv) non-interest income adjusted to exclude the bargain purchase gain on assets acquired and liabilities assumed from Doral Bank (the “Doral Bank transaction”) in the first quarter of 2015 and other-than-temporary impairments on investment securities, (v) non-interest expenses adjusted to exclude acquisition and conversion-related costs incurred in the Doral Bank transaction, and (vi) pre-tax earnings adjusted to exclude the bargain purchase gain on the Doral Bank transaction and related acquisition and conversion costs in the first quarter of 2015 and a prepayment penalty income on a large commercial mortgage loan paid-off in the fourth quarter of 2014. Investors should be aware that non-GAAP financial measures have inherent limitations and should be read only in conjunction with the Corporation’s consolidated financial data prepared in accordance with GAAP.

Management believes that these non-GAAP measures enhance the ability of analysts and investors to analyze trends in the Corporation’s business and to better understand the performance of the Corporation. In addition, the Corporation may utilize these non-GAAP financial measures as a guide in its budgeting and long-term planning process. Any analysis of these non-GAAP financial measures should be used only in conjunction with results presented in accordance with GAAP.

The release includes a reconciliation of these non-GAAP financial measures to the GAAP financial measures, except for the adjusted pre-tax earnings measure included below:
