On April 29, 2013 iTalk Inc. announced that it has signed a Letter of Intent to acquire RocketVoIP, Inc., an established 10-year-old residential and business broadband VoIP phone service provider.

This potential acquisition remains subject to, among other things, iTalk Inc. and RockVoIP Inc. completing customary pre-closing due diligence and entering into a Definitive Agreement. The Definitive Agreement is expected to be signed by all parties on or before the end of May 3rd, 2013. There can be no assurance that any transaction will be completed as proposed or at all.
