Item 1.01 **Entry Into a Material Definitive Agreement.**

On September 28, 2006, Ampal-American Israel Corporation (the Company) entered into an agreement with Jack Bigio, the President and Chief Executive Officer of the Company, with respect to the termination of his employment with the Company.
