("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli communications operator, announces Moody's publication: "Moody's Investors Service today downgraded the corporate family rating of Partner Communications Company Ltd. ("Partner" or "the company") to Ba1 (one notch) from Baa3. The outlook is stable. The rating action mainly reflects Partner's changed financial profile following its acquisition by Scailex, together with a liquidity profile that relies on ongoing external funding to meet near-term debt maturities"

The Company provides mobile communications services to over 3 million subscribers in Israel (as of December 31, 2009). Partner's ADSs are quoted on the NASDAQ Global Select Market™ and its shares are traded on the Tel Aviv Stock Exchange (NASDAQ and TASE: PTNR).

Partner is an approximately 45%-owned subsidiary of Scailex Corporation Ltd. ("Scailex"). Scailex's shares are traded on the Tel Aviv Stock Exchange under the symbol SCIX and are quoted on "Pink Quote" under the symbol SCIXF.PK. Scailex currently operates in three major domains of activity: 1) the sole import, distribution and maintenance of Samsung mobile handset and accessories products primarily to the three major cellular operators in Israel; 2) distribution and sale of various manufacturers' mobile handsets, accessories and provision of maintenance services, through a chain of retail stores and booths ("Dynamic"), to end customers of Cellcom (as part of the acquisition of the controlling stake in Partner, Scailex announced to Cellcom the termination of the distribution agreement through Dynamic, effective July 1, 2010 and on Jan 17, 2010 Scailex announced the sale of Dynamic's activity to Cellcom) and; (3) management of its financial assets.
