PARTNER COMMUNICATIONS ANNOUNCES  
RECEIVING A LAWSUIT AND A MOTION FOR THE  
RECOGNITION OF THIS LAWSUIT AS A CLASS ACTION

Rosh Ha'ayin, Israel, May 1, 2012 - Partner Communications Company Ltd. ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli mobile communications operator, announces that it was served with a lawsuit and a motion for the recognition of this lawsuit as a class action, filed against Partner on April 30, 2012 in the Jerusalem District Court.

The claim alleges that Partner does not fulfill an obligation to grant a monetary refund as set forth in the agreements of certain subscribers.

If the lawsuit is recognized as a class action the total amount claimed against Partner is estimated by the plaintiffs to be approximately NIS 92 million.

Partner is reviewing and assessing the lawsuit and is unable, at this preliminary stage, to evaluate, with any degree of certainty, the probability of success of the lawsuit or the range of potential exposure, if any.
