- (1) Since 4/9/03, Mr. Schear has been granted a total of 33,428 Common Shares as "restricted stock" (the "Shares") under the terms of the Vornado Realty Trust (the "Company") 2002 Omnibus Share Plan (the "Plan") as follows: (i) 27,428 Shares were granted on 4/9/03, with the shares vesting in equal portions over a 4-year period with the remaining portion vesting in January of 2007, (ii) 4,000 Shares were granted on 2/6/04, with the shares vesting in equal portions over a 5-year period with the remaining three portions vesting in January of 2007, 2008 and 2009 and (iii) 2,000 Shares were granted on 2/8/05, with the shares vesting in equal portions over a 5-year period with the remaining four portions vesting in January of 2007, 2008, 2009 and 2010. Mr. Schear continues to beneficially own 32,944 of these Shares in the aggregate.
