(collectively, the Partnerships). H&F Investors IV (Bermuda), L.P. (HFI IV Bermuda) is the sole general partner of the Partnerships. H&F Corporate Investors IV (Bermuda), Ltd. (HFCI Bermuda) is the sole general partner of HFI IV Bermuda. A five member investment committee of HFCI Bermuda (Investment Committee) has investment discretion over the securities.
- (2) Mr. Goldstein is not a member of the Investment Committee and has no pecuniary interest in the Partnerships. Mr. Goldstein disclaims beneficial ownership of the Common Shares beneficially owned by the Partnership, including the 576 Common Shares described herein.
