(1) 100% of the shares subject to the option are immediately exercisable. However, all unvested shares of common stock underlying the option are subject to a right of repurchase held by the Issuer, which right of repurchase will lapse as the shares vest according to the following schedule: 25% of the shares subject thereto vest on August 28, 2008, with 1/48th of the shares vesting monthly thereafter, such that the option will be fully vested on August 28, 2011.
