- (1) Disposed of pursuant to the Agreement and Plan of Merger between Issuer, Zoran Corporation ("Zoran") and Maple Acquisition Corp. dated September 7, 2010 (the "Merger Agreement"), in exchange for \$2.92 per share in cash.
- (2) Each restricted stock unit represents a contingent right to receive one share of Microtune common stock.  
Pursuant to the Merger Agreement, the restricted stock units were assumed by Zoran and shall represent a contingent right to receive
- (3) 126,858 shares of Zoran Common Stock based on the Exchange Ratio (as defined in the Merger Agreement) established three days prior to Closing.
- (4) Pursuant to the Merger Agreement, the option vested in full immediately prior to the effectiveness of the merger.
- (5) Pursuant to the Merger Agreement, the stock options were cancelled upon the effectiveness of the merger in exchange for a cash payment equivalent to \$99,963.16 which represents the excess of \$2.92 over the per share exercise price of the stock options.
