- (1) Shares held following the reported transactions include 113,402 restricted stock units, which are subject to forfeiture until they vest.

Under the terms of the restricted stock unit grant agreement, 1/2 of the total number of units shall vest two years from August 15, 2012, the grant date, and the remaining 1/2 of the total number of units shall vest on the date that is four years from the grant date. Each unit represents a contingent right to receive one share of the Issuer's Class A Common Stock upon vesting.
- (2) This option was granted for a total of 84,000 shares of Class A Common Stock. 1/2 of the total number of shares issuable under the option vests two years from August 15, 2012, the grant date, and the remaining 1/2 of the total number of shares vests on the date that is four years from the grant date.
