## Explanation of Responses:

- (1) On September 20, 2013, the reporting person mistakenly filed a Form 4 reporting the vesting of 1,042 restricted stock units granted March 27, 2012. No restricted stock units granted March 27, 2012 vested on September 18, 2013; the restricted stock units that vested September 18, 2013 were in fact granted June 28, 2010 and are reported in Table I and not as a derivative security on Table II. As of September 18, 2013, the reporting person only owned 62,694 shares of common stock.
- (2) Each restricted stock unit represents a contingent right to receive one share of HomeAway common stock.
- (3) On March 27, 2012, the reporting person was granted 11,561 restricted stock units. Six and one quarter percent (6.25%) of the restricted stock units will vest at the end of each quarter over a period of four years, measured from June 1, 2012, subject to continued service through each such vesting date.
- (4) As discussed in Footnote 1, on September 20, 2013, the reporting person mistakenly filed a Form 4 reporting the vesting of 1,042 restricted stock units granted March 27, 2012. No restricted stock units granted March 27, 2012 vested on September 18, 2013. As of September 18, 2013, the reporting person in fact owned 7,948 restricted stock units.
