- (1) This sale was made in connection with Mr. Wegleitner's Rule 10b5-1 Trading Plan, which was adopted on May 20, 2014. This price represents the weighted average sale price of the shares sold in multiple transactions at prices ranging from \$13.35 to \$13.83 per share. Upon request by the staff of the Securities and Exchange Commission, Infinera Corporation (the "Company") or a security holder of the Company, Mr. Wegleitner will provide full information regarding the number of shares sold at each separate price.
