#### OVERVIEW

The output figures for both the UK and AmerGen nuclear plant remain in line with plan.

#### UK - Nuclear

##### Planned Outages

- A statutory outage was completed at Torness and another started at Hinkley Point B.
- A refuelling outage was carried out on one reactor at Dungeness B.
- Low load refuelling was carried out on one reactor each at Hinkley Point B, Hunterston B and Heysham 2.

#### UK - Coal

##### Planned Outages

- One unit at Eggborough returned from planned maintenance outage. Another unit remained on outage in connection with the installation of flue lining as part of the FGD programme.
