Unilever NV announces that on 30 April 2007 it purchased 600,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.52 and euro 22.54 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 131,113 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 62,375,773 Unilever NV ordinary shares in treasury, and has 1,652,351,927 Unilever NV ordinary shares in issue (excluding treasury shares).
