Joint statement by Verizon and MCI

In response to ACTel-Wilkie claims

This material is entirely predictable, given the interests of those behind it. As Verizon and MCI explained in their filings with the FCC, it ignores the facts, tries to create some new ones, and relies on 20 year-old assumptions. The Verizon-MCI transaction will benefit customers and the economy while allowing the new combination to compete effectively in a changing marketplace. Nobody can control this new marketplace there are many domestic and international players. In fact, Verizon-MCI will have only a 16-22 percent share of the enterprise market. It is ridiculous to claim there will be collusion why else would Verizon invest in MCI except to compete in this new global marketplace?
