John Varley on the importance of staying focused

It s just very important indeed that our customers don t feel that we re, in some sense, distracted because of this merger. The merger is in the interests of customers, it s in the interests of employees, it s in the interests of shareholders but we must not allow ourselves to be distracted. That is the most important message that our colleagues can give our customers. In terms of information flow, I commit to communicating frequently to all my colleagues across the Barclays Group on the progress of this merger. And it s important that people understand that it takes some time, it s quite a complicated piece of engineering putting resolutions to shareholders, having the relevant shareholders vote. That will takes some months. So it s all the more important, by consequence, that we don t take our eye of our customers needs - because they expect us to be there for them today.
