**Item 1.01 Entry into a Material Definitive Agreement**

On May 21, 2007, Spectra Energy Capital, LLC ( Spectra Energy Capital ), a wholly-owned subsidiary of the registrant, entered into a \$1,500,000,000 Credit Agreement among Spectra Energy Capital, the banks listed therein, JPMorgan Chase Bank, N.A., as Administrative Agent and Citibank, N.A., as Syndication Agent (the Credit Agreement ), which provides for a revolving credit facility expiring on May 21, 2012.

A copy of the Credit Agreement is attached as Exhibit 10.1 to this Current Report on Form 8-K and is incorporated herein by reference.

**Item 1.02 Termination of a Material Definitive Agreement**

In connection with the execution of the Credit Agreement, Spectra Energy Capital terminated (1) its existing \$600,000,000 Amended and Restated Credit Agreement, dated June 29, 2006, among Spectra Energy Capital and the banks listed therein, and (2) its existing \$350,000,000 Credit Agreement, dated as of November 28, 2006, among Spectra Energy Capital and the banks listed therein.
