**Hsinchu, Taiwan, August 21, 2009** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of July 2009.

Revenue for the month of July 2009 was NT\$1,086.1 million or US\$33.1 million, an increase of 5.3% from the month of June 2009 and a decrease of 30.2% from the same period in 2008. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.80 against US\$1.00 as of July 31, 2009.)
