**ChipMOS REPORTS JANUARY 2010 REVENUE**

**Hsinchu, Taiwan, February 22, 2009** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of January 2010.

Revenue for the month of January 2010 was NT\$1,243.9 million or US\$38.9 million, a decrease of 2.4% from the month of December 2009 and an increase of 71.2% from the same period in 2009. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$31.94 against US\$1.00 as of January 29, 2010.)
