On March 4, 2013, US Airways Group, Inc. ( US Airways ) and AMR Corporation ( AMR ) each received a request for additional information (also known as a second request ) from the U.S. Department of Justice pursuant to the Hart-Scott-Rodino Antitrust Improvements Act of 1976, as amended, in connection with the proposed merger transaction between US Airways and AMR. A copy of the joint press release issued by US Airways and AMR relating to the second request is attached as Exhibit 99.1 to this Current Report on Form 8-K and incorporated herein by reference.

#### Additional Information and Where To Find It

This communication does not constitute an offer to sell or the solicitation of an offer to buy any securities or a solicitation of any vote or approval. The proposed merger transaction between AMR and US Airways will be submitted to the stockholders of US Airways for their consideration. AMR expects to file with the Securities and Exchange Commission (SEC) a registration statement on Form S-4 that will include a prospectus of AMR and a proxy statement of US Airways, and US Airways expects to file with the SEC a definitive proxy statement on Schedule 14A. AMR and US Airways also plan to file other documents with the SEC regarding the proposed transaction.
