**Item 1.01. Entry into a Material Definitive Agreement**

On November 11, 2013, Murphy Oil Corporation (the Company ) entered into an agreement with Wells Fargo Bank, N.A. to effect a variable term, capped accelerated share repurchase transaction (the ASR ) to repurchase an aggregate \$250 million of the Company s common stock. The Company will repurchase shares under the ASR as part of the board authorized program to repurchase up to \$1 billion of the Company s stock as previously announced on October 16, 2012 and recently extended to April 15, 2014. The Company had earlier repurchased an aggregate of \$500 million of the Company s common stock under previously announced ASR transactions.
