**Item 1.01 Entry into a Material Definitive Agreement.**

On July 11, 2018, Santander Consumer USA Inc. (the Company ) entered into a Tolling Agreement (the Tolling Agreement ) with FCA US LLC (the FCA ). Pursuant to the Tolling Agreement, among other things, the parties agreed each party shall fully preserve and retain its respective rights, claims, and defenses as they existed on April 30, 2018 with respect to the Master Private Label Financing Agreement between the Company and FCA entered into on February 6, 2013 ( MPLFA ). The MPLFA was filed as Exhibit 10.4 to the Annual Report on Form 10-K filed by the Company with the Securities and Exchange Commission on February 28, 2018.

The foregoing description is qualified in its entirety by reference to the full text of the Tolling Agreement, a copy of which is filed as Exhibit 10.1 to this Current Report on Form 8-K and is incorporated herein by reference.
