(1) 1-for-1.

The shares of phantom stock become payable, in cash only, at the election of the reporting person either (1) in a lump sump payable no later than 60 days following the termination of the reporting person's service as a director or (2) in annual installments for a period of 'x' years (not to exceed 10).

(3) After giving effect to the transaction reported in this line item of Table II, the number of derivative securities beneficially owned was 639.0231; however, on July 7, 2006, Helmerich & Payne, Inc. effected a 2 for 1 stock split. As such, the number of derivative securities beneficially owned as reported in this line item is 1,278.046.
