- (1) This grant was approved by the issuer's board of directors on February 26, 2008, subject to the officer's execution of a restricted stock award agreement and the payment of a purchase price equal to \$0.001 per share, which occurred on April 4, 2008.
- (2) The shares underlying this restricted stock award will vest in three equal annual installments beginning on February 26, 2009, subject to the officer's continuous service with the issuer as of the vesting date.
- (3) The shares underlying this restricted stock award are eligible for vesting in four equal annual installments beginning on February 26, 2009, the anniversary of February 26, 2008 (the "Vesting Commencement Date"). In the event the financial objectives for a particular year are not achieved, the shares that otherwise would have vested at the end of such year will vest on February 26, 2013, the fifth anniversary of the Vesting Commencement Date, subject to the officer's continuous service with the issuer as of such date.
