- (1) The restricted stock units were granted to Mr. Jones under the Company's 2005 Long-Term Incentive Plan as part of his compensation for employment. Each restricted stock unit represents a contingent right to receive one share of TCBI common stock.
 - (2) One third of the restricted stock units vest in four equal annual installments beginning January 27, 2010. The remaining two thirds are subject to performance-based vesting and will vest on January 27, 2014 unless certain performance measures for the Company are met prior to such date. Vested shares will be delivered to the reporting person within 2 1/2 months following the close of the calendar year in which the restricted stock units vested.
 - (3) Shares are held by G&M Partners Ltd., of which Mr. Jones is the Managing General Partner
