(1) Brink's Units were credited to the Reporting Person's account under the DSAP as a result of an annual allocation, in accordance with the terms of the DSAP. The number of Brink's Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$22.50, which is the average trading price of Brink's common stock on June 1, 2010, calculated in accordance with the terms of the DSAP.

(2) Includes a total of 109.70 Brink's Units representing shares of Brink's common stock that were credited to the Reporting Person's account under the DSAP on March 1 and June 1, 2010 as a result of dividend payments, in accordance with the terms of the DSAP.
