- (1) Restricted shares granted pursuant to the Invacare Corporation 2003 Performance Plan in an exempt transaction under Rule 16b-3. These shares vest in 25% increments over four years commencing November 15, 2011.
- (2) Held by a local bank as Trustee for an IRA Trust.
- (3) No transaction is being reported on this line. Reported on a previously filed Form 3, Form 4, or Form 5.
- (4) The reporting person holds previously reported options to buy 37,913 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 1994 Performance Plan and the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between November 14, 2000 and August 20, 2008, at exercise prices between \$21.0938 to \$47.01 per share, will expire between November 14, 2010 and August 20, 2018 and became or will become exercisable between December 31, 2001 and September 30, 2012.
