(1) partner interest and a 0.5% general partner interest in the partnership and the reporting person's spouse holds a 18.05999% limited partner interest and a 0.5% general partner interest in the partnership. The reporting person disclaims beneficial ownership of common stock held by the partnership except to the extent of his pecuniary interest therein.
