The Restricted Stock Units will vest and convert into common stock in four equal installments on the first, second, third and fourth anniversaries of the grant date.

- (7) Each Restricted Stock Unit is the equivalent of one share of Forrester Research, Inc. common stock.
- (8) On August 1, 2016, the reporting person was granted 9284 Restricted Stock Units that vest and convert into common stock in four equal and consecutive installments beginning on the first anniversary of the grant date.
