(2) Shares issued to the Reporting Person under the Logitech International S.A. 2006 Stock Incentive Plan in lieu of cash compensation for Board fees, at the election of the Reporting Person.

(3) The reported amount represents the purchase price on the SIX Swiss Exchange of CHF 46.18, as converted into U.S. dollars at the exchange rate of 1 CHF to U.S. \$1.0296, as in effect on September 5, 2018.
