Item 3. Sales of Securities and Use of Proceeds.

During the period covered by this report, the Guarantor and the Bank (and together with the Guarantor, the “Registrants”) issued on December 8, 2017, GBP 650,000,000 3 month £ Libor +0.23% CB35 Covered Bonds due December 8, 2022. The lead managers for the transaction were HSBC, Lloyds Banking Group and RBC Capital Markets.

The net proceeds from the sale of the Series CB35 Covered Bonds were added to the Bank’s general working capital and will be used for general working capital purposes.
