 - (2) Includes 559 RSUs acquired in the company's dividend reinvestment plan with accrued dividend equivalents.
 - (3) Includes 52,700 RSUs that may be settled only for shares of common stock. RSUs generally vest one year after the grant date and, on the settlement date, are convertible into shares of common stock on a one-for-one basis.
