a) declared a common stock dividend for the second quarter ending June 30, 2015, of \$0.12 per diluted share, payable July 15, 2015, for shareholders of record as of June 30, 2015;

b) declared a dividend for the second quarter ending June 30, 2015, of \$0.5344 per diluted share, for the Company's 8.55% Series A Cumulative Preferred Stock. This dividend is payable July 15, 2015, for shareholders of record as of June 30, 2015;

c) declared a dividend for the second quarter ending June 30, 2015, of \$0.5281 per diluted share, for the Company's 8.45% Series D Cumulative Preferred Stock. This dividend is payable July 15, 2015, for shareholders of record as of June 30, 2015; and

d) declared a dividend for the second quarter ending June 30, 2015, of \$0.5625 per diluted share, for the Company's 9.00% Series E Cumulative Preferred Stock. This dividend is payable July 15, 2015, for shareholders of record as of June 30, 2015.
