- (1) In accordance with the terms of the Overseas Shipholding Group, Inc. 2004 Stock Incentive Plan (the "2004 Plan"), these 438 shares of common stock were surrendered to Overseas Shipholding Group, Inc. upon the January 10, 2008 vesting of 1,363 shares (the "Vested Shares") of the reporting person's restricted stock in payment of the reporting person's tax withholding liability incurred as a result of the vesting of the Vested Shares.
  - (2) These shares of common stock were granted pursuant to the 2004 Plan and are subject to vesting restrictions. The reporting person becomes vested in one fourth of such shares on each of the first, second, third and fourth anniversaries of the date of grant.
  - (3) Of these 17,744 shares of common stock, 13,619 shares are subject to vesting restrictions as of January 11, 2008.
