As of the date of this Schedule 13G: i) Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), holds 3,887,725 warrants to purchase the Issuer's Common Stock, and is thus the beneficial owner of 3,887,725 shares of the Issuer's Common Stock; and ii) Millenco LLC, a Delaware limited liability company ("Millenco"), is the beneficial owner of 50 shares of the Issuer's Common Stock. The warrants have an exercise price of \$6.50 per share and expire on September 24, 2011, or earlier upon redemption.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the manager of Millenco, and may be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies or Millenco, as the case may be. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Millenco.
