Clients of FEIM have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. First Eagle Value in Biotechnology Master Fund, Ltd. ("FEVBM"), a Cayman Islands company for which FEIM acts as investment adviser, may be deemed to beneficially own 1,536,160 of the 2,298,660 shares (assuming exercise of Series A and Series B warrants to acquire 762,500 shares), which equates to 3.80% of the Common Stock.
