- On 12/12/2006, Mr. Ehrich was granted 2 stock options, an option grant of 20,000 shares (19,823 NQ and 177 ISO) and a 2nd option, pertaining to Mr. Ehrich as an Inventor, for 500 shares (NQ). The original Form 4, filed on 12/13/2006, omitted the grant of 500 shares. This amendment is intended to correct that oversight.
