(1) Acquisition of common stock resulting from vesting of one-fourth of the restricted stock units granted to Mr. Schlachter on May 23, 2011.

(2) Disposition of common stock resulting from the withholding of securities for the payment of tax liability relating to the vesting of one-fourth of the restricted stock units granted to Mr. Schlachter on May 23, 2011.

(3) Acquisition of common stock resulting from vesting of one-fourth of the restricted stock units granted to Mr. Schlachter on May 23, 2012.

(7) As a result of the 10% stock dividend paid on September 20, 2012 and pursuant to anti-dilution provisions in AmTrust Financial Services, Inc.'s 2010 Omnibus Incentive Plan, 1,494 outstanding restricted stock units granted to Mr. Schlachter on May 23, 2011 and held on September 20, 2012 because 1,644 restricted stock units.

(8) On May 23, 2012, Mr. Schlachter received restricted stock units subject to a four-year vesting schedule, vesting 25% on the first, second, third and fourth anniversaries of the grant date. As restricted stock units vest, the vested units are automatically converted to vested common stock on a one-for-one basis on the vesting date.

(9) As a result of the 10% stock dividend paid on September 20, 2012 and pursuant to anti-dilution provisions in AmTrust Financial Services, Inc.'s 2010 Omnibus Incentive Plan, 1,448 outstanding restricted stock grants granted to Mr. Schlachter on May 23, 2012 and held on September 20, 2012 became 1,593 restricted stock units.

(10) On May 23, 2013, Mr. Schlachter received restricted stock units representing 1,864 shares subject to a four-year vesting schedule, vesting 25% on the first, second, third and fourth anniversaries of the grant date. As restricted stock units vest, the vested units are automatically converted to vested common stock on a one-for-one basis on the vesting date.
