- (1) as managing member of FJ Capital, has voting and dispositive power over the shares of the issuer held by FOF. Andrew Jose is a founding member of FJ Capital and sold 500 shares of the issuer. Andrew Jose has dispositive power on the shares of the issuer held by FOF.
  - (2) Because of the Reporting Person's relationship to FOF and Andrew Jose, the Reporting Person may be deemed to beneficially own the shares to extent of the greater of his direct or indirect pecuniary interests in the profits or capital account of FOF. Pursuant to Rule 16a-1(a)(4) under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), this filing shall not be deemed an admission that the Reporting Person is, for purpose of Section 16 of the Exchange Act or otherwise, the beneficial owner of any shares beneficially owned in excess of his pecuniary interest.
