- On August 21, 2018, Eagle Bancorp Montana, Inc. ("Eagle Bancorp"), Opportunity Bank of Montana, Big Muddy Bancorp, Inc. ("BMB") and The State Bank of Townsend entered into an Agreement and Plan of Merger (the "Merger Agreement"), pursuant to which BMB
- (1) merged with and into Eagle Bancorp (the "Merger"). In the merger, each share of MBM common stock was converted into the right to receive 20.49 shares of Eagle Bancorp common stock. The transactions contemplated by the Merger Agreement were consummated effective January 1, 2019 (the "Effective Date").
  - (2) Received in exchange for 1,313 shares of BMB common stock in connection with Merger. The Effective Date of the Merger was January 1, 2019, which was not a trading day. On December 31, 2018, the closing price of Eagle Bancorp's common stock was \$16.50 per share.
