## Explanation of Responses:

- (1) The phantom units are settled upon vesting in common units (on a one for one basis).
- (2) The phantom units are settled upon vesting in common units (on a one for one basis) or cash, at the discretion of the Issuer.
- (3) Twenty-five percent (25%) of the phantom units will vest of each of the first four anniversaries of February 23, 2015.
- (4) The phantom units do not expire.
- (5) Twenty-five percent (25%) of the phantom units will vest on each of the first four anniversaries of February 26, 2016.
- (6) Twenty-five percent (25%) of the phantom units will vest on each of the first four anniversaries of April 2, 2018.
- (7) Twenty-five percent (25%) of the phantom units will vest on each of the first four anniversaries of April 3, 2017.
- (8) Each phantom unit represents the right to receive between one and three common units of the Issuer upon vesting.
- (9) The phantom units will generally vest, subject to the Reporting Person's continued service through such date, on the earlier of a change in control transaction or November 20, 2022.
- (10) Represents the target number of common units that may be issued. The actual number of common units issuable upon vesting can range from 100% to 300% of this target and will be determined by multiplying the target award by the quotient of the fair market value of a common unit on the vesting date divided by \$16.50 and rounded to two significant figures. Upon vesting, the phantom units may be settled in common units of the Issuer or cash at the discretion of the Issuer.
