Each restricted stock unit represents a contingent right to receive one NMI Holdings, Inc. common share upon vesting and settlement. The restricted stock unit award is scheduled to vest as follows: (i) 2,333 units will vest based on continued service on the second anniversary date following the grant date, on May 30, 2014, (ii) 2,333 units will vest based on continued service on the third anniversary date following the grant date, on May 30, 2015, (iii) 3,113 units will vest after the per share stock price equals or exceeds \$14.00 for a 30-day trading period, and (iv) 3,110 units will vest after the per share stock price equals or exceeds \$16.00 for a 30-day trading period.
