As each Amending Registrant is required to file reports pursuant to Section 13 or Section 15(d) of the Securities Exchange Act of 1934, as amended, the "No" box on the Original Form 10-K should have been checked in the appropriate location as it is on the cover of this amendment. Except as described in this Explanatory Note, this Form 10-K/A does not modify, amend or update the Original Form 10-K or reflect events occurring after the filing of the Original Form 10-K.

The Original Form 10-K was a combined Form 10-K representing separate filings by each of the Amending Registrants and their affiliates, FirstEnergy Corp., The Toledo Edison Company, Jersey Central Power & Light Company, Metropolitan Edison Company and Pennsylvania Electric Company. However, this Form 10-K/A constitutes an amendment only to the cover page of the Original Form 10-K filed by each of the Amending Registrants.
