Goldman Sachs beneficially owns directly and GS Group may be deemed to beneficially own indirectly 562,350 shares of Class A Common Stock and Goldman Sachs also had open short positions of 53,461 shares of Class A Common Stock, reflecting changes due to exempt transactions.
