#### **Explanatory Note**

This Amendment No. 1 to Annual Report on Form 10-K/A amends the Annual Report on Form 10-K for the year ended December 31, 2014 of ION Geophysical Corporation ("ION"), which was filed with the Securities and Exchange Commission ("SEC") on February 17, 2015. This Form 10-K/A is being filed for the purpose of providing separate financial statements of INOVA Geophysical Equipment Limited in accordance with Rule 3-09 of Regulation S-X. The INOVA Geophysical Equipment Limited ("INOVA Geophysical") audited financial statements as of December 31, 2013, and for the years ended December 31, 2013 and 2012, and the Report of Independent Auditors, are filed as Exhibit 99.1 and are included as financial statement schedules in Item 15. "Exhibits and Financial Statement Schedules" of this Form 10-K/A. ION owns a noncontrolling equity interest (49%) in INOVA Geophysical, which ION accounts for under the equity method of accounting, and the financial statements of INOVA Geophysical as of and for the year ended December 31, 2014 were not available at the time that ION filed its Annual Report on Form 10-K in February 2015.

Rule 3-09 of Regulation S-X provides that if a 50%-or-less-owned person accounted for by the equity method meets the first or third condition of the significant subsidiary tests set forth in Rule 1-02(w) of Regulation S-X, substituting 20% for 10%, separate financial statements for that 50%-or-less-owned person shall be filed. The significance tests are calculated as of the end of each of ION's fiscal years and with respect to each fiscal year.

INOVA Geophysical met the significant subsidiary tests described above as of and with respect to ION's fiscal year and period ended December 31, 2014, and ION has therefore included in this Form 10-K/A the required financial statements for INOVA Geophysical.

The consent of Grant Thornton for INOVA Geophysical Equipment Limited is also filed as an exhibit to this Amendment No. 1 to Annual Report on Form 10-K/A. In addition, this Form 10-K/A includes an updated exhibit index in respect thereof and certifications under Sections 302 and 906 of the Sarbanes-Oxley Act of 2002. Except as described above, this Amendment No. 1 on Form 10-K/A is not intended to update or modify any other information presented in ION's Annual Report on Form 10-K for the fiscal year ended December 31, 2014, as originally filed. This Amendment No. 1 does not update or modify in any way the financial position, results of operations, cash flows or related disclosures in ION's Annual Report on Form 10-K, and does not reflect events occurring after the Form 10-K's original filing date of February 17, 2015. Accordingly, this Form 10-K/A should be read in conjunction with ION's other filings made with the SEC subsequent to the filing of its Annual Report on Form 10-K for the year ended December 31, 2014.
