- (1) On October 22, 2010, 2,443 securities held by Milgrat I (P6) were disposed of by gift to a custody account of which the reporting person does not have any pecuniary interest and was exempt from Section 16(b) of the Securities Exchange Act of 1934 pursuant to Rule 16b-5.
- (2) On October 22, 2010, 96,745 securities held by Milgrat I (P6) were transferred to Trust C and 2,443 securities held by Milgrat I (P6) were transferred to Lloyd I. Miller, III. Such transactions only effected a change in the form of beneficial ownership without changing the reporting person's pecuniary interest in such securities and was exempt from Section 16 of the Securities Exchange Act of 1934 pursuant to Rule 16a-13.
- (3) On November 18, 2010, 109,711 securities held by Milgrat I (A7) were transferred to Trust C.
