 - (1) On October 24, 2008, 5,500 already reported and vested stock units, granted February 18, 2003, were distributed to the reporting person, 3,330 stock units were distributed to the reporting person as shares of common stock (NTRS), and 2,170 stock units were withheld in payment of Federal, State and Medicare taxes.
 - (2) On October 24, 2008, 3,333 already reported and vested stock units, granted on February 15, 2005, were distributed to the reporting person, 2,018 stock units were distributed to the reporting person as shares of common stock (NTRS); and 1,315 stock units were withheld in payment of Federal, State and Medicare taxes.
