This Amendment No. 4 to Schedule 13G (this "Amendment No. 4") is being filed with respect to the Common Stock of Core-Mark Holding Company, Inc., a corporation organized under the laws of the State of Delaware (the "Company"), to amend the Schedule 13G filed on February 13, 2006 (as amended by Amendment No. 1 thereto filed on February 13, 2007, Amendment No. 2 thereto filed on August 13, 2007, and Amendment No. 3 thereto filed on February 13, 2008, the "Schedule 13G"). This Amendment No. 4 is being filed to disclose that the Offshore Fund no longer beneficially owns more than 5% of the Common Stock.
