By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) SAC Capital Advisors LP, SAC Capital Advisors Inc. and Mr. Cohen may be deemed to beneficially own 2,104,931 (a) Shares (constituting approximately 4.0% (a) of the Shares outstanding); (ii) CR Intrinsic Investors and Mr. Cohen may be deemed to beneficially own 310,000 (b) Shares (constituting approximately 0.6% (b) of the Shares outstanding); and (iii) Sigma Management and Mr. Cohen may be deemed to beneficially own 236,300 Shares (constituting approximately 0.5% of the Shares outstanding).
