Mr. Humphrey disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
- (8) On November 18, 2015 the Bain Entities distributed 265,917 shares of Common Stock to one or more members or partners of the Bain Entities, including 186 shares to Mr. Humphrey, in connection with certain charitable gifts made by such members or partners on November 18, 2015.
- (9) Mr. Humphrey made a charitable gift of all 186 shares of Common Stock that he received in connection with the distribution.
- (10) Each Restricted Stock Unit vests upon grant and represents the right to receive one share of Common Stock upon the earlier of May 11, 2020 or Mr. Humphrey's termination of service.
